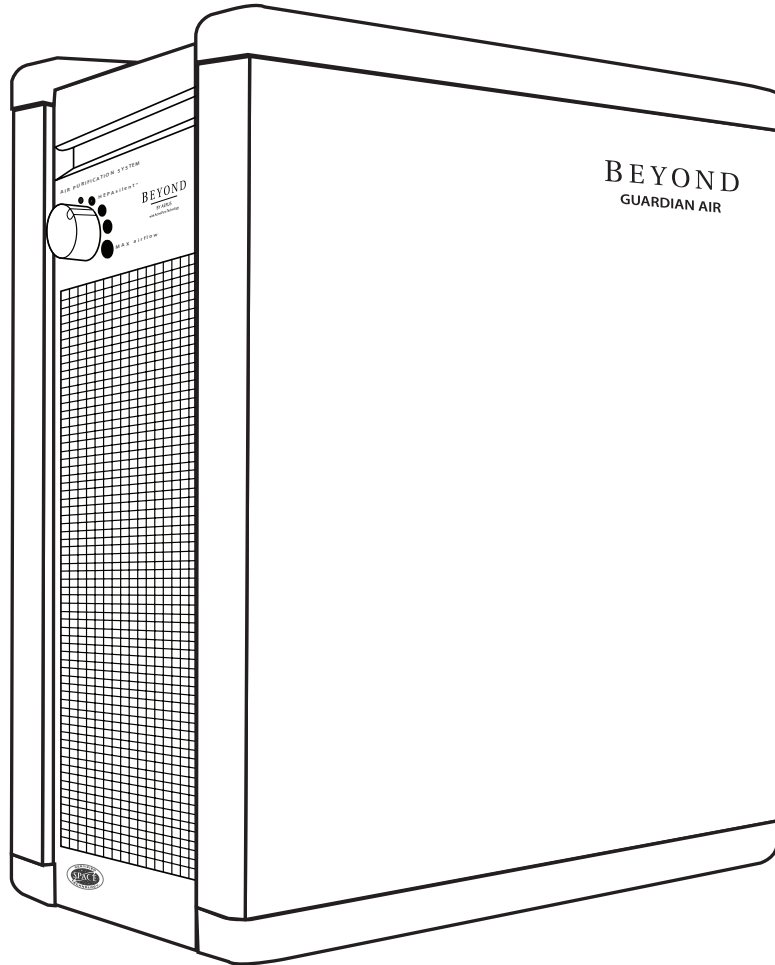

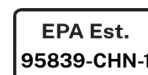

- This unit contains a UVC bulb
- Unintended use of the unit or damage to the housing may result in the escape of dangerous UVC radiation. UVC radiation may cause eye and skin irritation. Avoid exposing eyes and skin to ultraviolet radiation.
- **DO NOT** attempt to repair or adjust any of the electrical or mechanical functions of the Beyond Guardian Air. Contact Aerus® Customer Service for service information
- Unit will automatically turn off when the front door is open for cleaning and filter replacement; Read the maintenance instructions before opening the front door
- **DO NOT** use filters other than authorized Guardian Air filters
- **DO NOT** use outdoors or on wet surfaces
- **DO NOT** look directly at the UV light inside unit when operating. Eye damage may occur
- **DO NOT** allow to be used as a toy; Keep out of reach from children; close attention is necessary if operated near children
- **DO NOT** use with damaged cord or plug. If unit is not working as it should, has been dropped, damaged, left outdoors, or dropped into water, **DO NOT** use, and return it to a service center
- **DO NOT** pull or carry by cord, use cord as a handle, close door on cord, or pull cord around sharp edges or corners. Keep cord away from heated surfaces
- **DO NOT** unplug by pulling on cord. To unplug, grasp the plug, not the cord
- **DO NOT** handle plug or unit with wet hands
- **DO NOT** allow foreign objects to enter the ventilation or exhaust openings
- Keep hair, loose clothing, fingers, and all parts of body away from openings and moving parts
- Turn off all controls before unplugging

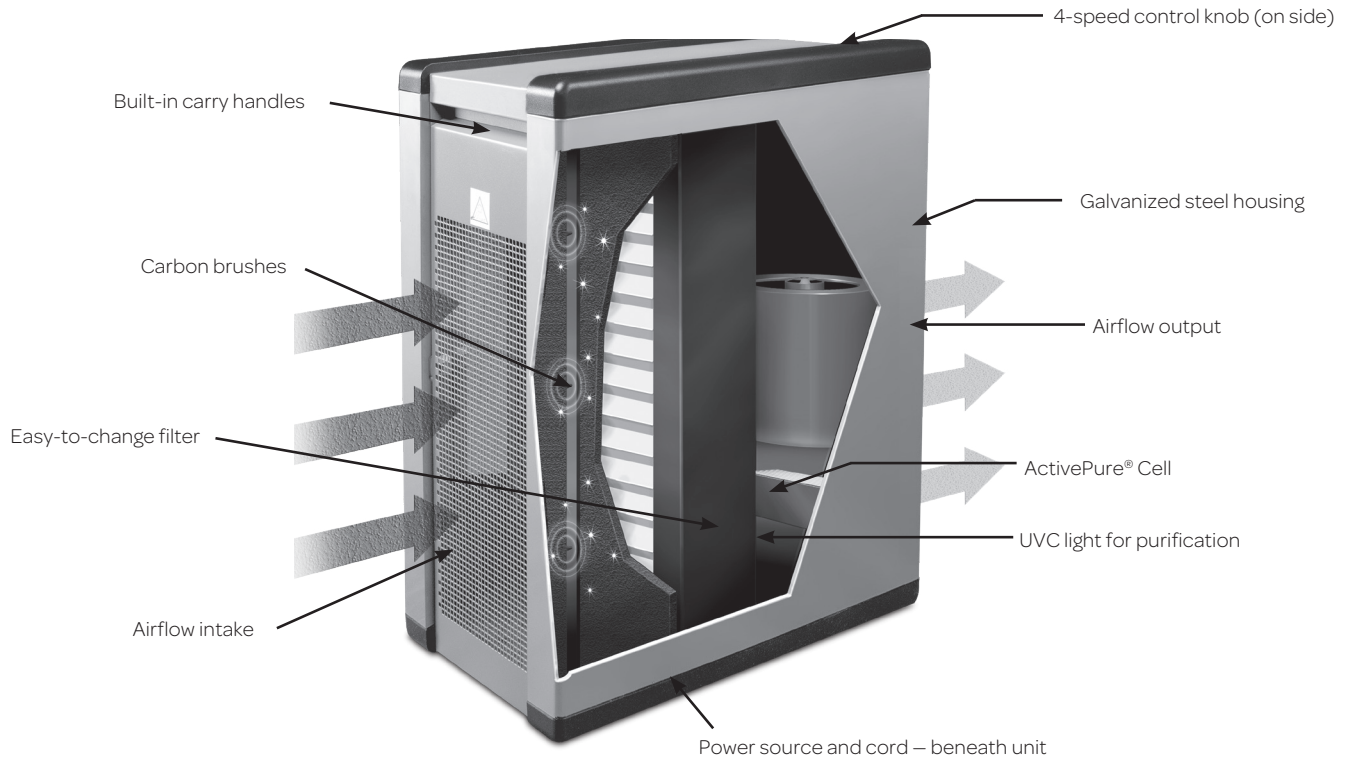

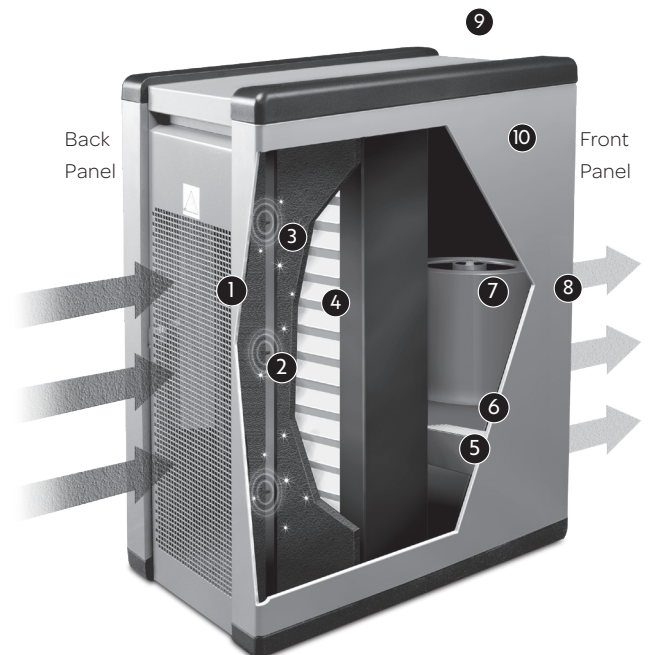
PRODUCT FEATURES

OPERATION



WARNING

DO NOT place the unit:

- Directly on or near soft furnishing, such as bedding or curtains
- Near electronically sensitive devices, such as a computer (within 6"-10")
- Near sources of heat, such as radiators, fireplaces, or ovens
- Near oxygen tanks or other combustible gases
- Near water, outdoors, or in a damp or wet area(s), such as bathrooms

1. Take your Beyond® Guardian Air unit out of the shipping carton and remove all protective materials.
2. Place the unit in a location away from the wall that allows air to move freely into, around and out of the unit. The rear of the unit requires one inch or more of open area to allow unrestricted airflow.
3. Attach cord to unit, if required. Plug the cord into a working electrical outlet.
4. When turning the unit on, turn the speed control to MAX airflow for a few minutes of fast initial purification.
5. After a few minutes, adjust the control to the desired speed.

NOTE: Safety switch automatically turns power off when door is opened.

SETTINGS

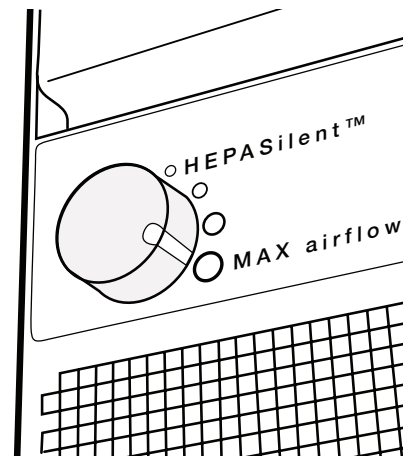
When turning the Beyond Guardian Air on, turn the speed control to maximum airflow for a few minutes of fast initial cleaning. Then adjust the control to the desired speed.

There are four settings on the Beyond Guardian Air:

1. HEPASilent™
2. Moderate fan speed (for normal use)
3. High fan speed (for a large room)
4. Maximum operation (for fast initial cleaning)

For best results, run your Beyond Guardian Air 24 hours a day, 7 days a week, giving you the benefits of ActivePure® day and night.

NOTE: Safety switch automatically turns power off when door is opened.



MAINTENANCE

Our air purifiers are designed to help improve indoor air with minimum impact on the environment.

The Aerus® HEPA particle filter is made of polypropylene, an eco-friendly plastic. Our filter contains no aluminum, triclosan or other chemical additives.

All major parts are made from high-quality galvanized steel, not plastic. The steel housing is noise-muffling, providing quiet operation. The external parts have been powder coated for endurance and environmental protection.

The Beyond® Guardian Air is energy efficient. From lowest to highest speed, it uses from 23 to 80 watts – no more than a lightbulb.

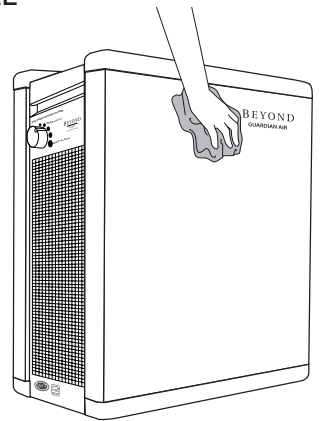

KEEP YOUR BEYOND GUARDIAN AIR LOOKING GOOD AND WORKING WELL

The Beyond Guardian Air features award-winning design, materials and workmanship.

Keep your unit in top condition with these cleaning tips:

- Always unplug unit before cleaning
- Wipe the exterior with a soft, clean, damp cloth
- Vacuum the small inlets on each end panel with a soft brush attachment
- Clean inside the filter chamber by opening the front door of the unit and opening the door of the filter chamber (right-hand side)
- Never clean with gasoline, chemical solvents or corrosive materials – they may damage the surface



FILTERS

Aerus HEPA technology makes the Beyond Guardian Air incredibly quiet. Units come with one HEPASilent™ particle filter (installed).

The Aerus HEPA particle filter is made of polypropylene, which mechanically filters out airborne particles (dust, pollen, pet dander, mold spores and other airborne particles). To maximize filter effectiveness, particles are negatively charged before reaching the filter.

For optimal performance Aerus recommends that you replace filter at least every 6–12 months, depending on usage.


NOTE: Use only Aerus HEPA particle filters to ensure proper functioning and to qualify your unit for full warranty coverage.

UVC BULB & ACTIVEPURE® CELL

To maintain optimal performance, the UVC Bulb and ActivePure® Cell should be replaced annually.






STEP 1:

side




STEP 2:
Remove old filter




STEP 3:

Aerus® warrants the Beyond Guardian Air, to the consumer subject to the conditions below, against defects in workmanship or material, provided that the products are returned to an Aerus location within 1 year of date of purchase*.

MAINTENANCE REQUIREMENTS

Failure to use and maintain your Beyond Guardian Air in accordance with your Owner's Manual will void this warranty, including but not limited to:

- Replacing your HEPA filters with genuine Aerus filters every 6–12 months, depending on usage
- Replacing the UVC bulb with a genuine Aerus part annually
- Replacing the ActivePure® Cell with a genuine Aerus part annually (proof of change may be required)

Servicing your Beyond Guardian Air by parties other than an authorized Aerus location and/or using parts other than genuine Aerus parts will also void this warranty.

HOW TO OBTAIN WARRANTY SERVICE

Customers must contact their distributor or Customer Service and provide proof of purchase within the above time periods. We will repair or replace and return the product, without charge and within a reasonable period of time, subject to the conditions in the above paragraphs, if its examination shall disclose any part to be defective in workmanship or material. If we, in our discretion, are unable to repair the product after a reasonable number of attempts, we will provide either a refund of the purchase price or a replacement unit, at the company's option.

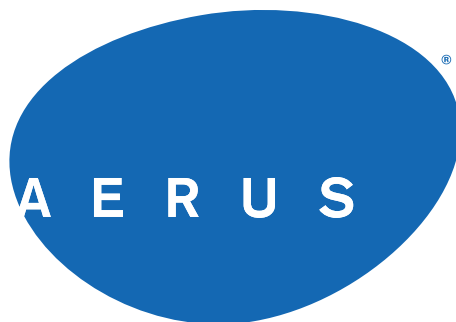
