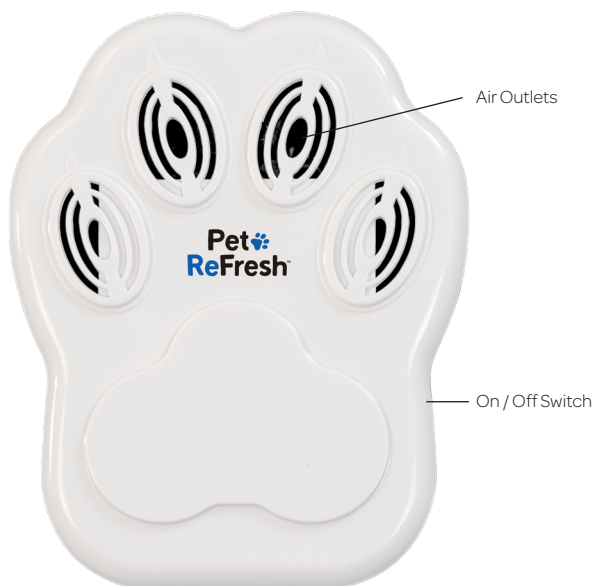

INSTALLATION & OPERATION

1. Take your Aerus® Pet ReFresh unit out of the shipping carton and remove all protective materials.
2. The Aerus Pet ReFresh comes with various colored decals which allows you to optionally customize your unit. Decals are removable and reusable. See product features section on page 5 for color options.
3. Plug your unit into any standard 120 VAC electrical outlet and move the switch to the "ON" position.
4. To turn the unit off, move the switch to the "OFF" position.



MAINTENANCE



- Disconnect power before servicing unit
- Do not spray with cleaning products or allow mists or other types of moisture to enter unit. Cleaning products or moisture will damage the unit and such damage is not covered by the product warranty

The Aerus® Pet ReFresh is low maintenance. Once every month the air inlet and outlet must be vacuumed (see diagram on page 5).

- Disconnect the unit and gently brush back and forth over the openings using an accessory brush attached to a vacuum cleaner (running on its lowest power setting) to help remove internal and external contamination

NOTE: Do not vacuum the unit for more than 10 seconds at a time or blow air into the unit.

- Periodically wipe the unit with a dry cloth

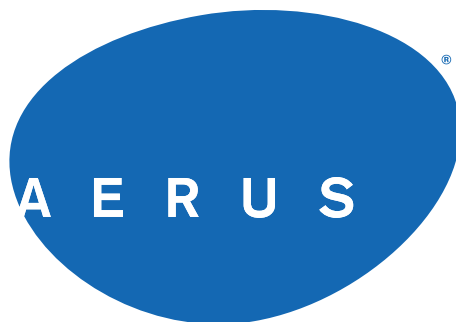
